Job Title: Assembly Operator

Job Functions:

Leads, assists, and performs the duties of the Fabricator. Assembles, repairs, and finishes tanks. Sprays up components according to specifications. Insures products meet specifications as to dimensions and assembly standards. Responsible for the accomplishment of work performed by assigned personnel under the direction and authority of the supervisor.

Essential Duties and Responsibilities: (Other duties may be assigned)

- Leads, assists, and performs the duties of the Fabricator beyond skill level of Fabricator Attendant under the direction and authority of the supervisor.
- Lays out tanks from shop drawings and certifies that the tanks meet those standards as to dimensions and assembly specifications.
- Assembles tanks per instructions, written procedures, blueprints, and drawings.
- Inspects finished assembly per layout specifications, and assembly standards.
- Uses power tools to fabricate, prepare and install fittings.
- Operates portable power tools, assembly jigs and handling equipment, etc., to repair tanks by grinding, patching, sanding, and hand layup.
- Procures and inventories materials, supplies, and resins used in assembly and repair.
- Completes records and reports (including, but not limited to, work performed on each tank, etc.).
- Operates material handling equipment as required.
- Grinds and/or regrinds tanks/shells/parts.
- Sets up and operates fabrication machinery (including, but not limited to, drill press, molds, spray-up gun, portable spray-up, saw, hand tools, etc.).
- Produces end caps, special products, and accessories (including, but not limited to, reservoirs, end caps, hold down straps, manways, fittings, nozzles, etc.).
- Checks and cleans equipment (including, but not limited to, end cap machinery, guns, choppers, etc.); notifies appropriate personnel of any equipment or quality problems and takes corrective action within the scope of the job.
- Adjusts spray gun and equipment to insure proper resin and glass amounts.
- Removes fabricated products from molds and transports to designated areas.
- Inspects products against standards (including, but not limited to, manufacturing records, amount of resin and glass used, items fabricated, UL requirements, etc.).
- Participates in the safety and good housekeeping programs as established within the plant.
- Performs other related duties consistent with the nature of the job as directed by the supervisor.
